

EEGS STUDENT CHAPTER PETITION FORM

REQUIREMENTS TO FORM AN EEGS STUDENT BRANCH

Student members at any college or university having accredited programs in the Geological Sciences, or Geological Engineering, may petition the Board to form or to become part of a Student Chapter. Two (2) or more Student Members (a president and a vice president – responsible for running the Chapter and growing the membership within the Chapter) with the endorsement of the potential faculty advisor(s), may petition the Board for Chapter approval. Chapter approval shall be subject to official recognition by the college or university as a student organization subject to the rules and regulations of the educational institution and managerially and financially independent of the Society.

Each Student Chapter shall have a Student Chapter Advisor. In the case of a single institution Chapter the faculty advisor shall be the Student Chapter Advisor. Students without a faculty adviser may petition the Board to form a chapter and be assigned an external faculty adviser. To receive the student chapter benefits associated with SAGEEP, each chapter without an internal faculty adviser must have at least one student presenting at SAGEEP each year. For a joint Chapter, the Student Chapter Advisor shall be designated as one (1) person from the group for faculty advisers. A Student Chapter Advisor must be a Member, Emeritus Member or Associate Member. Students or advisers from institutions who wish to make a joint student chapter with neighboring institutions may petition the Board for permission to do so. The petition shall include all institutions proposed to be part of the joint student chapter and will be considered by the Board on a case-by-case basis.

All members of a Student Chapter shall be Student Members of the Society in good standing. Each Chapter shall hold at least two (2) meetings per school year. The Chapter shall submit an Annual Report to the Membership Committee by the end of January for inclusion in the Society's Annual Corporate Meeting. The Annual Report shall summarize the activities of the Chapter in the preceding year. The Annual Report will be reviewed by the Academic and Student Affairs Manager and the Board to determine the status of the Student Chapter.

In the event that a Faculty Advisor leaves an academic institution where a Chapter or a portion of the Chapter has been established, an interim advisor who is not a Member of the Society may serve for a period of not more than one (1) year without approval of the Board. If a Student Chapter Advisor of a joint Chapter departs, a successor shall be immediately appointed from the group of existing faculty advisers.

Each Student Chapter shall strive to further the goals of the Society and the profession. They shall not make statements for the Society.
